Introduction

 - appoints the New Trustee to be a trustee of the Scheme and to act jointly with the Continuing Trustees for all the purposes of the Scheme, and
 - removes and discharges the Retiring Trustee from the office of trustee of the Scheme.
- 2 The New Trustee agrees to act accordingly.
- The Continuing Trustees and the New Trustee declare that they will hold all monies, deposits, securities, investments, property and income for the time being representing the assets of the Scheme upon the trusts of the Scheme and subject to the powers, conditions and provisions which apply to the Scheme.
- The New Trustee and each of the Continuing Trustees confirms that he/she is not disqualified, prohibited or suspended from being, or ineligible to be, a trustee of the Scheme under the Pensions Act 1995.
- This deed may be executed in any number of counterparts and by the parties to it on separate counterparts, each of which will be an original, but all of which together will constitute one and the same instrument.
